The unaudited Net Asset Value per Ordinary Share (“NAV”) of PXP Vietnam Fund Limited (“the Company”) as at the close of business on 29 November 2013 was US\$6.144.

The year-to-date performance figures are calculated by reference to the NAV / Viet Nam Index at the end of the last calendar year. Viet Nam Index performance is presented in US dollar terms.

Share capital

The issued capital of the Company is 12,000,000 Ordinary Shares with voting rights.
